Cancellation Waiver & Post Departure Plan

Payment of the per person Cancellation Waiver guarantees full refund on all payments (including deposit), except the waiver fee itself, made for tour rates in case of cancellation up to the time and date of departure due to personal illness (medical documentation required) or death of a member of the immediate family (official documentation required). If the passenger must return early due to personal illness (medical documentation required) or death of a member of the immediate family (official documentation required), payment of the waiver fee guarantees a refund for the unused services. Payment of the waiver guarantees your return air transportation utilizing your original airlines tickets with no additional supplement. The waiver does not cover return transportation costs other than return air transportation utilizing original airline tickets. The waiver fee is fully refundable outside of 75 days prior to departure (Final Payment Deadline). The waiver fee does not cover any single supplement charges which arise from an individual's traveling companion electing to cancel for any reason prior to departure. Under this scenario, the single supplement will be deducted from the refund of the person who cancels. Division of the charges is to be determined by the two passengers. The waiver is non-transferable and valid for each applicant only. The waiver does not cover any services such as airline tickets not purchased through Premier World Tours LLC dba Chamber Explorations (hereafter Chamber Explorations). Chamber Explorations can assume no responsibility for and cannot be held liable for any wrongful, negligent or unauthorized acts or omissions of any group travel organizer or travel agent other than that of Chamber Explorations itself and its own employees. The waiver is not applicable for River or Ocean Cruises. **Post Departure coverage (Accident & Medical) is included in plan cost.** Please note that your cancelled check or credit card statement will serve as your receipt for the plan.

Waiver Definitions

"Immediate Family Member" - One's parents, wife or husband, children, and brothers and sisters.

"Unused Services" - Land tour services such as missed hotel overnights, hotel taxes, hotel portage, meals, shows, attractions and other admissions. Unused Services does not constitute Tour Director salary, pre paid commissions, motorcoach services, motorcoach driver salary or airline tickets.

"Return Early" - Land tour services must be terminated for a passenger to be eligible for an Unused Services Claim. Passengers that depart a tour due to illness or death of immediate family then rejoin the tour are not eligible for an Unused Services Claim.
